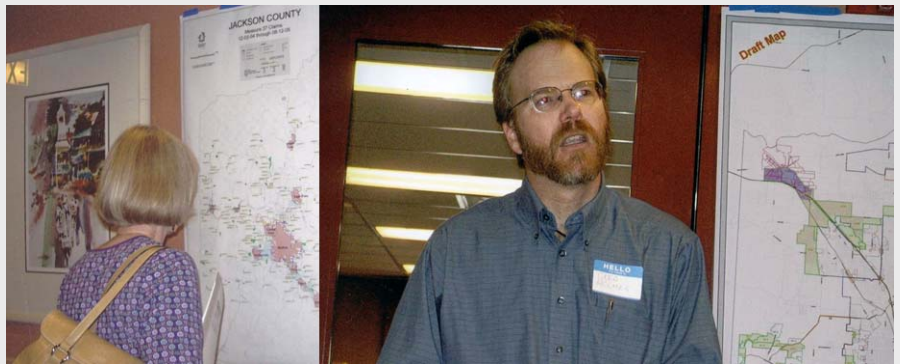

LAND USE

“Jackson County’s first zoning ordinance will be in effect by the time you read this. It is the result of 4 years of work on a comprehensive plan and zoning maps and ordinances. Josephine County is still working on theirs. But what of the other counties which are not progressing well? The last legislature passed SB100 in its closing days, after many changes and rewrites in this LAND USE bill. As a state program item, land use will be studied by League; we will note what legislation we now have, with special emphasis on acquisition of and compensation for land and taxation policies. Material will appear in the January ’74 bulletin from state. Meanwhile, suggested reading is “The Use of Land;” and belong to the LAND USE COMMITTEE.” Helen Thomas, Chairlady

Greg Holmes with 1,000 Friends of Oregon referred to SB100 in his October presentation to the League. He stated that in the 1970s more than 10,000 citizens came out to support innovative land-use laws in Oregon.

Thirty-one years later, Jackson Counties and many of its municipalities are

in the throes of planning for a doubling of the region’s population. The project, managed by Rogue Valley Council of Governments is called “Regional Problem Solving” and “Now X2”. Committees are meeting regularly to plan the future face of Jackson County. The meetings are open to the public. Did you know?

There are between 23,000 - 25,000 homeless children in Oregon.

Homeless Youth are the fastest growing segment of the homeless population.

Oregon's only dedicated source of funding for this population comes from Federal grants of the Runaway and Homeless Youth Act. Approx. \$25 Mio. Goes to only seven counties.

Homeless Youth Summit in Roseburg

I attended a Homeless/Runaway summit entitled "Invisible Youth" and found it most helpful for our LWVOR study. Dr. Susan Pickrel was the keynote speaker and in attendance at this meeting were over 200 people.

How can we determine the needs of youth who are homeless and make a plan to meet them? Some of the needs are services for boys, counseling, mediation, affordable housing, financial assistance, shelter, clothing, and Oregon Health Plan.

Our committee will be contacting local agencies and will be working on putting the "net" back into social services. We are planning a meeting on November 4th and we will have a panel address us at our December lunch meeting.

- Incarceration for one juvenile: \$48,500
- Adolescent drug treatment program: \$3,000—\$12,000
- Sheltering and other basic services: \$1,100—\$1,800

Dear Members,

We League members love our *Voters' Guide*. We all share the League's goal of providing excellent nonpartisan information to voters. Over the past 8 years, the state League has worked with members around Oregon to provide this information free of charge, in accessible formats, and to more and more citizens. Fortunately many individuals, businesses and foundations have supported us.

For 2004, the LWVOR Education Fund raised more than \$85,000 from foundations, businesses, local League boards, and direct mail solicitation of both League members and nonmembers. League members contributed almost \$24,000 of this amount and local League boards worked with us to raise over \$28,000 from their communities! The LWVOREF Board and I are very grateful for the hard work of our Development Committee and for this wonderful support from members.

In 2006 our printing and shipping costs will increase, although by how much we don't yet know. Our Development Committee is considering increasing our use of the Internet, but we think most voters are **not** ready to give up the printed guides.

One thing is abundantly clear. If we are to continue to reach out to more voters with free copies of the printed *Voters' Guide*, we need your help. In 2004, contributions from local Leagues varied a great deal. We are hoping for more equitable sharing and increased support this time around. Access and Availability of Health Care in the Rogue Valley

Six members studied this topic by interviewing doctors and medical staff, listening to speakers, visiting facilities, examining surveys and previous studies. We found that there were some successes in the local healthcare, such as cooperation between agencies and a lot of volunteer work by doctors and other medical staff, but there are definitely gaps in the safety net.

Here in Southern Oregon, doctors are reimbursed for Medicare patients at a lower rate than in other areas and states. If you want a hip replacement and a doctor who is anxious to do it for you, go to Florida! This situation has led to a shortage of internists on our valley. Some will not accept all Medicare and Medicaid patients and others move away. Even in October, 2005 this has not improved much as the medical schools are not turning out internists, but rather specialists. Internists are the doctors who treat the elderly, since there are few gerontologists in the Rogue Valley. The local situation is that Medford internists are still accepting new Medicare patients but that is not the case in Ashland. People from Grants Pass, Ashland and even Northern California are making appointments with Medford physicians, which in the long run will lead to a deteriorating situation here. The good news is that we have two new neurosurgeons, who have replaced the two who retired or moved away.

The cutbacks in the Oregon Health Plan have reduced the number of low-income people who qualify, even though the Governor has tried to preserve programs for health coverage for children and pregnant women, state police crime labs and prescription drugs for seniors.

Although some excellent medical care is available in this area with the latest in medical technology and the best of medical staff being available for some patients, especially in a medical magnet like Medford, there is a crisis in attracting and retaining doctors and medical staff for various reasons.

CITIZENSHIP TUTORING PROGRAM - by Shiena Polehn, LWVRV

Members will be sorry to hear that a worthy program sponsored by the Human Rights Coalition of Jackson County and the Rogue Valley League of Women Voters is drawing to a close. The chief initiators of this program were John Almaguer, a local immigration attorney who was then the president of HRC, and Jean Milgram of our League who organized the meetings and workshops, bought the materials and matched the mostly Hispanic students with their tutors. Maria Swann of the Medford Police Department was an invaluable liaison with the students and Shiena Polehn, a former US citizenship teacher, helped with the workshops.

We can count the program as a success from the number of talented and willing volunteers who came forward, but we ran into difficulties in three areas:

- 1) getting the students to come to regular tutoring sessions and staying with the program. In some cases it was from lack of communication and transportation, but also the student's work and family schedule or from moving out of the area.
- 2) completing the necessary paper work for the citizenship(we were told very clearly not to attempt to fill out the papers ourselves) and
- 3) not having enough qualified students sent to us for tutoring.

However, those volunteers who participated in the program enjoyed the experience, especially establishing a relationship from someone from another culture whom they would not normally meet. Those tutors who still have students want to continue working with them.. One volunteer in particular has blossomed through contact with her student and their lesson has become the high point of her week.

We are discontinuing training of new tutors, but will support existing tutors until their students become US citizens.

Out of this program have come some worthy new citizens, maybe not as many as we hoped, but it has been very worthwhile. Thanks to all you League members who have given us encouragement and support.
