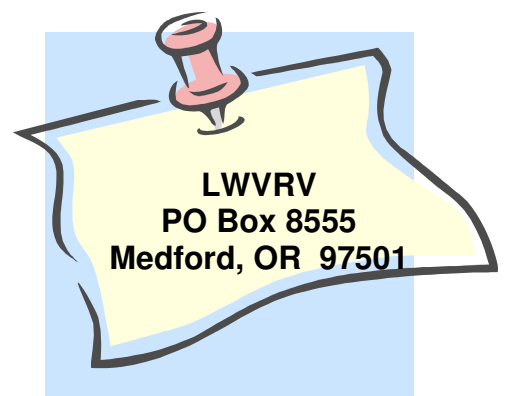

LWVRV BOARD MINUTES

LWVRV Board Minutes, September 13, 2011

Medford Heights Townhouse Association Clubhouse, 314 Eastwood Drive, Medford

Call to Order: President Barbara Davidson called the meeting to order at 1:35 p.m.

Present were: Normary Barrett, Willie Bijon, Barbara Davidson, Carol Ingelson, Carole Levi, Cynthia Lora, Vanya Sloan, Lorraine Werblow

Welcome and Brief Check-in

President's Remarks: the position of vice-president becoming president is not a given. Perhaps there could be co-chairs or make this 'portfolio' for one person as Program Coordinator. \ Suggestions: 1st VP – Lorraine Werblow; 2nd VP –Iris Milan (duties and responsibilities to be worked out later). May be a need for a separate folder for "Merger".

Treasurer's Report – 09/11/11 – Ending Balance: \$\$2,515.49

Willie Bijon gave a report re the need to address a revised budget, changes due to the merger with LWV Ashland, with transfer of assets, membership numbers, etc. Also, PMP confusion: based on membership of last year and the fact of different fiscal years (Ashland = May 1st; LWVRV = June 1st).

Membership: Membership Directory: policy on cost of mailing newsletters – should there be a specific cost to those without email (to members and non- members)? The treasurer mentioned the need for a separate budget category for charge of mailing newsletters.

Need to revise the membership directory: Cynthia Lora, with Vanya Sloan and Carole Levi (to help with the technology and details). Cynthia Lora and Carol Wilder can have the membership directory by end of October, hopefully.

Discussion re student dues: no decision. The Ashland League tried, with \$20; Portland League has \$25; each league sets its own policy.

Possibility of having a membership table at the Oct. conference – on hold.

Duties of Vice Presidents: 1st VP: conduct meetings in absence of president; focus on public relations in the community (at present Mickey Ketchum does this for LWVRV). 2nd VP: perhaps serve as program coordinator. Lorraine and Barbara will look into by-laws (plus online) to determine.

Voters Voice: Carole Levi – deadline Saturday 9/24/11. Please use "Word doc" if you have a Mac. Need for a new membership form.

Meeting location: The Phoenix Library appears to be too small for general program meetings. The Talent Library has a larger room but there may be a conflict. Change from Oct. 13 to Oct. 20?– Barbara has the contact this month. There is a need to accommodate both leagues as to meeting day.

Carole Levi, Voters Voice – she needs to have a day compatible with the deadline for the newsletter.

Every Woman Every Child: UN Initiative

As the annual General Assembly meeting of the UN opened on September 20, 2011, most of the global attention is monopolized by the Palestinian avowed intention to apply for full membership in the UN as the 194th member through the Security Council.

Sadly, however, little is said or written about another important event at the UN this General Assembly session -- a high level event chaired by the Secretary-General Ban Ki-moon to save the lives of women and children. Opening this event he said, " In our time it is wrong to allow women and children to die when we have the tools to save them ... I am happy to say that one year later we are delivering." The Norwegian Prime Minister, Jen Stoltenberg reported that in the past year 600,000 more children survived to grow up and go to school and an additional 70,000 mothers survived childbirth but too many are still dying of preventable causes.

According to an AP report [9/20/11], Dr. Julio Frenk, Chairman of World Health Organization's *Partnership for Maternal, Newborn and Child Health* and Dean of the Harvard School of Public Health, about \$45 billion has been committed to the UN Initiative *Every Woman Every Child* passing the initial pledge of \$40 billion made a year ago. It is encouraging to note that some of the poorer countries are assuming responsibility for their development needs.

The AP report also notes that Bangladesh plans to train 3,000 midwives and double the percentage of births in the country with the help of skilled health worker. Also, that Nepal had begun training 10,000 more skilled birth attendants.

A collective effort was necessary to meeting the UN's goal of saving lives of 16 million mothers and children by 2015. Worldwide, an estimated eight million children die before reaching age five and about 350,000 women die during pregnancy or childbirth.
