### Illuminate the importance of public involvement in our government process

Sunshine Week is celebrated, nationwide, each year in mid-March. The event coincides with National Freedom of Information Week and James Madison's March 16th birthday. The purpose is to raise public awareness to the importance of open government. Originally Sunshine Week was the brain child of journalists in response to assaults on various open records laws in Florida. The base of the celebration has broadened and the League of Women Voters is just one of hundreds of organizations that form a coalition of partners in celebration of Sunshine Week.

Much of the work of LWVRV focuses upon the importance of open government. The league's positions on citizen participation and access to government include the following:

"The League of Women Voters believes democratic government depends upon the informed and active participation of its citizens and requires that governmental bodies protect the citizen's right to know by giving adequate notice of proposed actions, holding open meetings, and making public records accessible." "We must promote an open governmental system that is representative, accountable and responsive." LWVUS Representative Government position

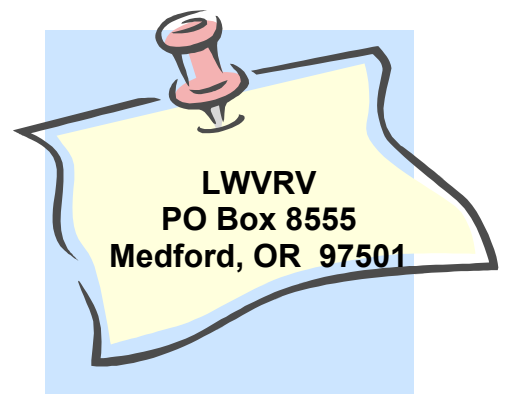

# COUNTY BUDGET STUDY GROUP

The County Budget Study Group began meeting Dec. 12 and has met four times. We have had one knowledgeable guest and are inviting several more. Study Group representatives met with Dave Gilmour, current chair of the Board of Commissioners, who provided us with valuable information. We have learned that:

the County Budget is a massive document, complicated and confusing, with some jargon and a great deal of detailed information.

Oregon state law requires that the budget be presented in a certain way.

the Adopted Budget is available in its entirety on the county webpage: [www.co.jackson.or.us](http://www.co.jackson.or.us)

the County Budget Committee (CBC) of 6 is composed of the 3 County Commissioners (BOC) and 3 laypeople appointed by the BOC for 3 year staggered terms). All County Budget Committee meetings are public.

the CBC met December 8, but the minutes are not yet available.

the CBC will meet in March for "Budget Review" with each Department Director.

the CBC will hold public hearings on the budget in April, with time scheduled for public input.

at the end of the public hearings the CBC will deliberate and develop a recommended budget.

in June the BOC will formally adopt the budget.

We have recommended that this study continue into next year, so that we may fully understand the budget and the process involved, and so we may develop recommendations on what might be the most useful next step to share what we have learned with the public.

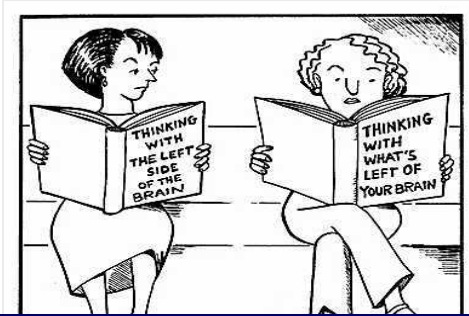

# LAND USE ISSUES

LWVRV President Trish Bowcock has tried to clarify some issues of the RPS process from the Policy Committee and the DLDC. RVLWV has opposed the currently proposed Participants Agreement (PA) because the proposed PA bound the participants to sign off on a draft regional plan prior to the formal land use hearing on the plan. Our concern is that prior agreement to the plan would jeopardize the effect of public comment during the legally mandated public hearing. We have never been opposed to any less binding PA prior to the public hearing. We do support the concept of regional planning. However, the DLCD Director Whitman has indicated that PA doesn't have to be signed by all participants prior to the public hearings while John Renz, the local DLCD representative, disagrees. Also, Jacksonville has refused to sign it now. Ashland hasn't deliberated on it or signed the PA yet, but they will consider signing the accord at its March 3rd meeting.

Previously, I mentioned the Regional Economic Analysis the local pear industry had sent to the governor and the state legislature which was of some interest to them. I recently reviewed the report and therefore, I want to respond to it. The analysis in the report claims the pear industry in Jackson County is a high value food business which must be able to raise sufficient capital for investing in additional acreage to increase efficiency and expand the industry to remain competitive. The report maintains that the industry capital reserves are frozen in land and other assets and that increased access to capital must come from more flexible land use policy such as the ability to subdivide and develop housing on their orchard lands. Supposedly they would have the ability to borrow more capital because of the increase value of their orchard lands. However, the increase price of farm land encourages development of these lands. Presently, most available orchard lands in EFU zoning are up for sale at nearly \$70,000 per acre which is too high for farming such vineyards. The report supports the notion that "grapes are not necessarily planted on the same types of soils as pears and may require different micro-climates than pears." Presently, much of the local acreage of Bear Creek Valley vineyards are planted on old pear orchard lands, and I estimate that about 2/3rds of the present orchard lands could be planted to vineyards.

Historically, three of the largest pear operators, Naumes, Associated Fruit, and Harry and David, expanded and developed new and improved orchards in the 1980s and 1990s under the present zoning laws. They also relied on more current practices by consulting professional horticulturist in the upgrades. Also, Naumes sold considerable acreage of rouged out orchards at development prices and did not replace the acreage or restore older acreage. Harry and David, kept most of their rouged out orchard lands. Other individually owned orchards that were rouged out and sold were not replaced with new acreage. So it is unlikely that any orchardist would use the capital from orchard sales at development prices to expand or upgrade their orchards.
