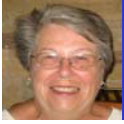

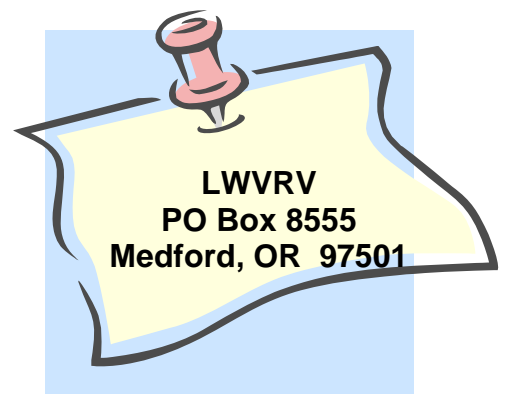

## VOTERS' INFORMATION

**All ballots must be returned to a county elections office or designated drop site by 8pm on November 2.**

In September 2010, the United Nations General Assembly will once again take stock and assess progress toward meeting the eight aspirations of the *Millennium Development Goals*. Two of the eight goals are focused directly on women's betterment. They are *Promote Gender Equality* [Goal 3] and *Improve Maternal health* [Goal 5]; a third, *Improve Child Mortality* [Goal 4], is closely related women's situations.

On July 2, 2010, the UN Secretary-General Ban Ki-moon announced, "The Newest Member of the UN Family has been Born" . UN Women. The UNSG noted that "by bringing together four parts of the UN system dedicated to women's issues, Member States have created a much stronger voice for women and gender equality at the global level" and further, " You have combined global norm-setting responsibilities in one UN entity and given it the means to provide operational support to countries to implement those norms and standards"

On September 14, 2010 UNSG Mr. Ban named former Chilean president Michelle Bachelet to head the new entity, UN Women. Announcing this major appointment Mr. Ban observed,"Ms. Bachelet brings to this critical position a history of dynamic global leadership, highly honed political skills and uncommon ability to create consensus and focus among UN agencies and many partners in both public and private sector."

While we should celebrate this accomplishment, we cannot ignore or forget that 1,000 women still die needlessly every day from complications during pregnancy and childbirth. Women in poorer countries are 36 times more likely to die from pregnancy-related causes than those in rich countries -- 99 percent of the 358,000 maternal deaths reported in 2008 were in developing countries. Major causes of maternal mortality include: bleeding after childbirth, infections, hypertensive disorders and unsafe abortions according to the World Health Organization. As UNSG Mr. Ban said, this situation is intolerable and unacceptable. We agree and hope that the new entity -- UN Women -- will aggressively go to work on all issues related to the empowerment and well-being of women and girls.


